Membership Definitions:

Resident Members – Families or individuals residing in the state of Wyoming.

Non-Resident Members – Families or individuals not residing in the state of Wyoming.

Junior Membership – Available to Converse County students who are not more than 20 years of age and whose parents or guardians are not members.

College Membership – Available to full-time college students age 20 – 25 who are not covered under family membership.

Senior Discount – Over 65: Deduct \$25.00 *per household* from yearly dues. Maximum allowable deduction is \$25.00.

New Member Initiation Fee – A one-time fee assessed for any family or individual who has not previously been a member of the Douglas Community Club. Single persons who wish to upgrade their membership to a family membership shall be responsible for the increased amount of the new membership initiation fee as well as the increased yearly membership fee.

Re-Admission Fee – A fee assessed for any family or individual who 1)has previously been a member during any of the past five years 2)paid a new member initiation fee and 3)has not paid a yearly membership fee for one or more years.

Memberships are billed yearly in February and are delinquent May 1st of that year. Delinquent memberships will be assessed a \$50.00 per month fine until dues are paid in full. Payment of membership constitutes agreement that your family members and/or guests agree to abide by the rules and regulations of the Douglas Community Club.

Use or Lose Policy: Any member failing to pay their monthly bill at the DCC restaurant/lounge within 60 days of the billing date will be considered delinquent and will be on public notice to be posted in the clubhouse until payment or payment arrangements have been made with the concessionaire. If payment has not occurred within 90 days, membership shall be suspended until payment arrangements have been made and approved by the concessionaire. In the event a member is suspended twice in one membership year, membership will be revoked. Any future membership in DCC will be treated as a new membership and will require the initiation fee to accompany membership dues with the application.
